## Co-sanctioned NCHA-USCHA event rules/format:

The Cutters In Cowtown NCHA-USCHA Co-sanctioned events will be double judged, comprised of one show wherein two judges independently score each entry. The contestants will be allowed to enter under one or both judges. Both judges will automatically score each contestant. Judges will be titled as NCHA judge A and USCHA judge B prior to the start of the contest. Each judge's score represents and pays a separate purse. Contestants that enter under a single judge A or B will be competing for a single purse with one associated payout. Contestants that enter under both judges will be entering to potentially earn monies under one or both judges. Scores

under both judges will be posted and announced after the class is complete. Double judged NCHA/USCHA co-sanctioned events with double payouts will charge an additional pro-rated office charge, as well as an additional entry fee. The additional entry fee is to be jackpotted at 100%. No additional cattle charges will be incurred. All entry fees and added monies will be equal under each judge. Co-sanctioned events will be in compliance with NCHA and USCHA rules. Each Judge will observe and be governed by rules for the appropriate association.
